Hands of the Carpenter provides assistance with automobile placement repair, maintenance and related education to enable low income single mothers and widows to maintain a job, get children to school, and keep medical appointments. This unique approach offers hope to a group who may be taken advantage of when in need of these services. In 2016, Hands served 218 different women, providing them with 465 services. Included were 22 placements, 144 repair jobs, 177 maintenance services and 122 vehicle education opportunities.
